

Nebraska Youth Camp Rental Agreement Information

Nebraska Youth Camp is operated to promote Christian fellowship, wholesome recreation and education. Conduct of any group which is not in accord with these purposes shall be considered sufficient reason for refusal of camp use. Our facilities are available for rental groups when there are no scheduled NYC activities on the calendar. Only current NYC corporate members may sign this rental agreement. The corporate member does not have to be present during the rental period but assumes responsibility for the group.

Groups, except extended family groups, wishing to rent the campground for a recreational camp for more than 48 hours are required to obtain their own camp permit from the State of Nebraska. Application for the permit must be made at least 30 days prior to rental. (<https://dhhs.ne.gov/Documents/Title-178-Complete.pdf#search=title%20178%20chapter%201>).

Rental rules and regulations

1. As a group leader, you are responsible for the actions of your group. It is our expectation that you will leave the grounds and facilities in the condition in which you found them, and that **you will assume responsibility for all loss and damage caused by your group** to Nebraska Youth camp grounds and facilities.
2. **Nebraska Youth Camp assumes no responsibility for property/belongings brought to camp.**
3. **SAFETY IS YOUR RESPONSIBILITY.** You are responsible for providing your own **first aid supplies and emergency transportation**. If an accident or incident does occur, the group leader will contact the camp caretaker to be sure proper paperwork documenting the accident or incident is completed.
4. **Posted sanitation regulations** for kitchen, bathhouses and cabins must be followed.
5. **Alcoholic beverages, smoking, gambling, drugs and any illegal activities are strictly prohibited.**
6. **Pets** are not allowed on NYC campgrounds.
7. **Firearms, hunting and trapping** are only permitted on the campground with advance approval of the Board of Directors.
8. **All outdoor fires** must only be built in established fire circles. Do not leave fires unattended. Fires must be doused with water. Please do not cut down any trees, alive or dead. Use only fallen, dead trees for firewood.
9. **Swimming** is at your own risk. No lifeguard is provided by NYC. All **boat users** must wear lifejackets. Please observe weight /seating restrictions for watercraft. Adult supervision is required for all youth at the lake.
10. **Fishing** is allowed at the lake for event guests only.
11. **Driving on the campground** is not permitted. Cars must be parked in designated areas.
12. **Posters or signs** may not be affixed to the walls of the dining hall by any means.
13. Please be responsible for your group's litter. **All articles and possessions must be removed promptly at the conclusion of the event. All trash from the event must be placed in the dumpsters.**

You will be notified within one week after receiving your request if the campground is available.

Following your event an invoice will be sent to you. Full payment is due within 30 days of billing. Your deposit will be mailed back to you after the campgrounds have been inspected and it has been found that no damages occurred.

It is your responsibility to report accurately the number of people that were present each day (determined by starting time). Please use form provided by the caretaker.
